City of Grand Forks Council Delegation

BACKGROUND: Council for the City of Grand Forks welcomes public input and encourages individuals and groups to make their views known to Council at an open public meeting.

Council needs to know all sides of an issue, and the possible impacts of any action they may take, prior to making a decision that will affect the community. The following outline has been devised to assist you in preparing for your presentation, so that you will understand the kind of information that Council will require, and the expected time frame in which a decision will be forthcoming.

Presentation Outline

Your Worship, Mayor Konrad, and Members of Council, I am here on behalf of: The Kettle River Watershed Authority

to request that you consider:

funding for the implementation of actions related to drought and flood management in the Kettle River Watershed Management Plan

The reason(s) that I am requesting this action are:

- 1. There is a great need for drought management in the Kettle River Watershed;
- 2. There is great need for flood management in the Kettle River Watershed; and
- 3. There is a great need for land owner/public education related to droughts and floods in the Kettle River Watershed.

I believe that in approving our request the community will benefit by:

- 1. Having a regionally supported Drought Response Plan in place;
- 2. Having increased public understanding of drought conditions and what is required of land owners; and
- 3. Having increased public understanding of the risks of living in a floodplain and mitigation measures that can be taken.

I believe that by not approving our request the result will be:

- 1. Lack of a regionally supported Drought Response Plan; and
- 2. Continued frustration and a lack of understanding by land owners of how to prepare for floods and droughts and how to respond in emergency situations.

In conclusion, I request that the Council adopts the following resolution:

1. We will support the development of the Regional Drought Response plan via funding (previously approved) and with staff or elected official support upon request (e.g Regional Drought Management team membership).

2. We will provide funding of up to \$15,000 to support the development of a floodplain education package and outreach program.

Your Worship, Mayor Konrad, and Members of Council, I/We are here this evening on behalf of:

Whispers of Hope Benevolence Association

To request that you consider:

rescinding the 6 month eviction notice for 7212 Riverside Drive.

The reasons that I/We are requesting this action are:

to prevent any closures or stop of services; many factors are currently preventing a smooth relocation within the given time frame.

I/We believe that in approving our request the community will benefit by:

having access to the Community Kitchen and free meals throughout the week. Thrift store would remain open to receive and process donations, to keep items from unnecessarily ending up in the landfill, and continue to generate revenue for our wages and charitable efforts. This would also allow our neighbours BETHS, the extreme weather shelter, the ability to finish their season and offer shelter to those who would be put out on the streets otherwise. This would allow us the ability to successfully relocate without a stop to service and without displacing existing/operating businesses.

I/We believe that by not approving our request the result will be:

a closure of the facility and (as temporary as possible) stop of services to vulnerable members of the community. This may leave people desperate and add stress to other supporting agencies or citizens who are not prepared (ex. access to public washrooms, food, public phone, personal hygiene products & beds and shower access through BETHS). Our facility also offers a gathering place for people to meet, network, find friendship or support, receive work experience and training, provide community service hours, seek other support agencies, or just plain come to socialize; a closure would have a negative effect on everyone who participates, especially those suffering from mental health illnesses.

In conclusion, I/we request that Council for the City of Grand Forks adopt a resolution stating:

the notice of eviction of 7212 Riverside Drive for Feb. 10th 2018 be retracted, allowing occupation until June 2018 as stated in the original lease agreement. We also ask that city council consider renewing and renegotiating a new lease agreement for the property, until an appropriate location for our operations can be ascertained.





there are species of raptor birds consisting of owls, hawks, woodpeckers, and bats, and several species of smaller birds, along with squirrels, mule deer,

and whitetail deer that live and nest all year in this Ponderosa pine forest.

the ever changing landscape of logging, encroachment of humans, who systematically destroy large and small tracts of forest leave the above

mentioned birds and animals and plants with no where to go, inevitably the result is going to be extinction.

these wonderful creatures that are a significant part of our heritage have no way to protect or defend themselves from the onslaught of mankind.

we have a moral and a legal obligation to not contribute to their demise. the Grandby Wilderness society along with First Nations. Central Okanagen Land Trust

and many other groups have recognized it is not a great price to pay to save the creatures that are no match for how man can decimate and drive them to extinction.

the following organizations have been contacted and are being asked to do all they can to preserve the Vienna woods as a forest treasure for now and for all the generations to come.

some of the groups are: Central Okanagen Land Trust, First nations Osoyoos band, Interfor in Grand Forks, OWL, green party mla Sonia Furstenace and her senior policy adviser Clair Hume.

some additional time is needed to have a plan in place as to the restoration and replanting of a portion of the Vienna woods that was destroyed.

I/We believe that in approving our request the community will benefit by:

the multitude of reasons this pine forest needs to stay is as follows:

first and foremost, protection of all the above mentioned species.

the air pollution scrubbing ability of the Pondorsa pine, of all trees, is known be one of the most effective trees to do this.

the noise buffer it provides between the city and the family residences beyond and around the pines.

the noise buffer it provides between Unifab and activity on the airport. replanting the decimated area would further enhance and improve this condition.

from a highest and best use perspective, a one time low cash benefit to cut down the remaining forest, is folly. from a commercial/industrial perspective, these industries are always in a state of flux, and large numbers of them go bankrupt and close in the first five years.

as a community we have seen many businesses come and go, and city resident who pays property taxes is left to suffer the loss of yet another deal gone bad.

there are many other city owned and privately owned commercial and industrial properties available for development. Donaldson drive, along the highway 3 corridor, and more.

many other communities across BC have adopted and embraced and made the concept of the preservation of nature a priority, we need to do what is right and adopt these same policies.

a wildlife preserve/community forest can last many lifetimes, for all to be enjoyed.

In conclusion: I/We request that Council for the City of Grand Forks adopt a resolution stating:

the 6.14 acres locally known as the Vienna woods be designated as a Wildlife Preserve Community Forest.

Two weeks ago fear swept through council chambers... A CAMPAC this week, relief.

At the March 1 council meeting, chambers were filled with residents from both the city and Area D begging council not to log the trees at the Vienna Woods: A committee was set up in hopes of finding a compromise. More than a compromise was made, a complete turnaround was presented at Monday's meeting with the motion to not log any of the trees and to contact the province researching ways of legally making the area a natural forest territory.

"They've (councilors) come to realize that there is longterm value to this grove of pines," said a delighted Gene Cook, who's family has been enjoying the Ponderosa Pines

since 1969. "I think the mayor. and council should be congratulated to have the foresight to understand that not everything 18 related to money and that this beautiful pine forest has great value as well."

The motion no trees inside Vienna Woods. the airport fences would be cut either. "We've received new information stating that there is no danger with the trees to aircraft at this time," informed/ Mayor Jake Raven.

Some concern was presented at the meeting. Coun. Neil Krog was in support of saving the trees, but felt the motion



also stated that Gene and Gloria Cook helped save the -photo, Katie Robinson

was going about it the wrong way. He was largely concerned with the other owners of the properties surrounding the city's property.

"I would hate to see us lock this property off and have development introduced up there surrounding this particular property," said Krog, who wanted to wait for more information with the strong intention of protecting the pines. "All I see with this motion is a reaction to protect it... that's not always the best way. I think a partnership with all governments is the best path we should be taking."

Along with finding out the school district's intention with their portion of the property, Krog wanted the Regional District of Kootenay Boundary included in the motion.

The majority of council didn't want to wait for more information, they wanted to show their concerned citizens that they are prepared to do whatever it takes to save this forest.

 "We're not trying to ram a motion in, but we do need something that will get the ball rolling with all the other parties," said Coun. Tom Shkrabuik.

Council passed an amended motion stating that their intent is to protect the area, but they require more information before they fully decide on what route to take. The next step is to approach the school district in hopes of creating a natural parkland partnership.

Hi Diane,

I understand that there may be a date change on the closure of Whispers of Hope facility. On October 10/17 on receipt of complaint, I inspected the Whispers facility and Kitchen. There were a number of deficiencies at that time. I discussed them with the manager and stated that I would re-inspect in one month. On November 16/17 I met with the manager to inspect the facility deficiencies. All of the deficiencies had been corrected except for the kitchen exhaust and hood system, which had a long expired cleaning decal attached. The manager had stated that she had contacted a hood and exhaust duct cleaning company from Nelson but they said that they would not be able to come until spring. I told her that was not acceptable and it needed to be cleaned right away. I instructed her to contact a company in the Okanagan and she agreed. Today I met with the manager. She still had not gotten the system cleaned.

As per the BC Fire Code section A-2.6.1.9.(3), In general, exhaust systems should be cleaned at intervals not greater than 12 months, but in the case of deep fat cooking, char broiling or similar cooking operations, the systems should be cleaned at intervals not greater than 3 months.

As the facility was scheduled to close in February, I have been lenient on shutting down the cooking system until it has been cleaned. Unfortunately the manager has been lax in sourcing out a cleaning company. With a delayed closure and because of the continued risk of fire, I will be forced to shut down the stove and exhaust system until it has been cleaned as per NFPA 96 and the BC Fire Code. I believe I have been more that reasonable as the manager has had an opportunity since October to have the system cleaned but has neglected to do so.

On October 10th, 2017, I accompanied Fire Chief Hariot to this facility to conduct a routine safety inspection. This was the first time I was there with the intention of inspecting, and I was more than surprised. What stood out the most for me was the condition of the electrical components, see attached. **This place is in need of an electrical review**. Unprotected, energized wires are surface mounted throughout and, although I am not an electrical inspector, my understanding is that this is clearly a safety concern.

An Occupancy Permit was issued for the facility in December, 2013, with the only new 'Building Code' work being the installation of the cooking facilities (gas stove and ventilation system). Apparently other minor renovations took place at that time as well (non-structural changes to some interior walls, repainting and reflooring) but there are no comments in the file about the condition of the electrical system. So it appears this electrical work occurred after the Occupancy Permit was issued. If a copy of the electrical inspector's approval cannot be obtained, then an electrical review should be done immediately.

We have spoken in the past about possible deterioration and organic growth issues within the building due to ongoing water ingress. This was restated in March, 2017, by an engineering company hired by the city to provide an analysis as to whether the building could be retained for the future, or whether it should be retired. Essentially, they concluded that the building could be retained if approximately \$312,000 of renovation work was done. To the best of my knowledge, no decisions have been made about this considerable expense but given that a new 'base building' (without tenant improvements) could be constructed for close to this amount, it seems unlikely that those funds would be injected into this building which was constructed over 50 years ago.

Lastly Di, I really need to express concerns that a fundamental building component does not exist in this building, that being a fire alarm system. When the number of occupants in the residential area (Beths) exceeds 10, a fire alarm system is required. Last October 30, before the facility opened, I posted an Occupant Load sign (see attached) because I did not believe this was known by the residents, or that this was just ignored. I am hearing now that the occupant load in the Beths area is almost always in excess of 10, and this is a real concern.

If the occupant load can be maintained at 10 or less, and if the electrical systems are corrected immediately, then I would be comfortable stating the place is safe to occupy for the time being. If this cannot be done, then the place should be vacated now.

The last four months of 2017 saw 48 calls in September, 47 in October, and 39 in November.

In 2016, we responded to 442 calls, 148 Fire, 56 Rescue, and 238 F/R.
