# Background

Our existing water, sewer, and electrical bylaws contain provisions which require us to continue billing utilities and to impose certain charges such as disconnection and reconnection fees without consideration for emergency situations such the one we are currently experiencing. In order to provide some financial relief for proper owners impacted by flooding, staff requires a resolution of Council to waive these fees.

Staff will take into consideration the underlying circumstances and will obtain management approval for any requests to waive administrative fees and late penalties or interest charges.

At this time staff is unable to estimate the loss of revenue as we do not know the actual number of households and businesses affected, or the time it will take for those properties to become reoccupied. The residential areas hardest hit are primarily water and solid waste pickup customers, with relatively few also having sewer and electrical services. Customers in the downtown core generally have all services other than solid waste collection.

# **Benefits or Impacts**

#### General

Residents of the City who have experienced devastating losses during the recent flooding will not be further burdened by being required to pay for services which they are not using.
