# 5. LATE ITEMS

a. Proposed Resolution to UBCM

Councillor Thompson

Mayor Baker introduced the reconsideration of the proposed resolution submitted through the Association of Kootenay Boundary Local Governments (AKBLG) to the Union of BC Municipalities (UBCM).

The revised wording was considered less inflammatory and may have a better chance of being passed.

R070/23/03/16 MOVED / SECONDED

THAT Council amend the wording of the UBCM resolution submitted through the AKBLG to read:

WHEREAS health care in British Columbia is inadequate to meet the needs of the population;

WHEREAS since 2001 Health Authorities have governed the provision of health care in their respective areas but are not held accountable for poor policy decisions and the negative impact they have on local communities;

BE IT RESOLVED that the Union of British Columbia Municipalities petition the Provincial Government to consider supplementing Health Authorities by including the responsibility of health care where there is a regional hospital and replacing such with Regional District Boards of Health responsible for health care;

AND FURTHER BE IT RESOLVED that Regional District Boards of Health responsible for health care must include representation from doctors, nurses, lab techs, and administration.

#### b. Travel to FCM Conference

Mayor Baker

Mayor Baker advised Council of his desire to attend the Federation of Canadian Municipalities (FCM) conference in May. Policy requires Council approval for travel to this conference.

The Mayor noted that Area D director Wiese would also be travelling, and that his travel could be covered by the RDKB should the Mayor of Trail choose to not attend.

Discussion included the budget impact of this trip. There have been adjusted requests by Council to attend the Union of BC Municipalities (UBCM) conference in September; the impact of these changes has not been fully calculated at this time.
