Purpose

To provide Council with the necessary information to deliver comment to the Liquor and Cannabis Regulation Branch (LCRB) regarding an application for amendment to a Liquor Primary Licence to increase the person capacity for The Bar + Kitchen located at 7319 2nd Street.

Background

The Liquor and Cannabis Regulation Branch (LCRB) has received an application for an amendment to a liquor primary licence to increase the person capacity for The Bar + Kitchen, located at 7319 2nd Street. Before the LCRB can decide whether to approve the application for the licence, Local Governments must first gather input from the community within the immediate vicinity of the establishment and provide comments on the application. Alternatively, Council may also choose to delegate the authority of providing comment on the application to Staff.

The proposal is for an increase in person capacity for The Bar + Kitchen. The current approved person capacity for the inside of the building is 30 and for the seasonal patio is 15, for an overall capacity of 45 persons. The applicant has applied to the Liquor and Cannabis Regulation Branch for a person capacity of 50 for the inside of the building and 20 for the seasonal patio, resulting in an overall capacity of 70 persons for the establishment.

The applicant acquired the services of an engineer to complete an assessment of the building to ensure the structure would meet the requirements of the proposed occupancy load. The engineer provided a list of recommendations that were completed by the applicant and subsequently inspected by the engineer. The engineer confirmed acceptance of the work.

Comments to the LCRB regarding an amendment to a liquor primary application for an increase in person capacity must speak clearly to the following items:

- The impact of noise on the community in the immediate vicinity of the establishment.
- The impact on the community if the amendment is approved.
- The views of residents, and a description of the method used to gather views.
- The local government's recommendations (including whether the application should be approved) and the reasons on which they are based.

These comments must consider:

- The proposed hours of service
- The occupancy load of the establishment

The impact of noise on the community in the immediate vicinity of the establishment	Noise is not expected to be an issue due to the commercial location.
The impact on the community if the application is approved	If the application is approved, the impact is expected to be positive in that it will support the growth of the local economy and increase the patrons visiting the downtown core.

The proposed person capacity and hours of the establishment present no immediate concerns to the City or to the public. The increase in capacity has the potential to create new jobs and help revitalize the downtown core of Grand Forks.
