#### 5. REGISTERED PETITIONS AND DELEGATIONS

a. Selkirk College and The University of Victoria

Presentation on a street outreach program for marginalized people in Grand Forks

Rescheduled from Dec 10, 2018 COTW meeting.

Ty Wright and Gwendilyn Grieves, fourth year nursing students from Selkirk College, presented a review of a street outreach study that they conducted over the previous three months as a research project and a description of the resource navigation tool they created to help refer people who need services. One component of their project was using a "street nursing kit" to provide Naloxone, sharps containers, vitamins, and other harm reduction equipment to marginalized residents.

Council discussed existing services and providers (local mental health, recovery team's health pillar)

An outreach program would include distribution of products from the street nursing kit, along with referrals to local services.

Harm reduction resources in West Kootenay communities are currently funded by ANKORS and Mental Health.

The Mayor will assist in collaborating with other agencies to direct a letter of support in the most effective manner.
